The Thompson's Station Fall Festival is a fundraising event for the Town of Thompson's Station Community Association (TSCA). The event is themed "The Dog & Pony Show" and includes dog and equine components in addition to live music, a chili cook-off, kids' activities and games, arts and crafts and more.

#### Schedule:

The Festival will be held on **Saturday, September 27, 2014** from 9:00 a.m. – 5:00 p.m. in Thompson's Station Park. **The craft fair will be open from 9:00 a.m. – 5:00 p.m**. All booths shall remain open for the duration of the event.

#### **Application Deadlines and Fees:**

**EARLY REGISTRATION**: \$75 (\$25 discount) | Applications and fees received/postmarked by **May 30, 2014**. **STANDARD REGISTRATION**: \$100 | Applications and fees received/postmarked by **August 29, 2014**.

LATE REGISTRATION: \$125 CASH ONLY | Applications received after August 29, 2014 - PENDING AVAILABILITY!

#### Arts and Craft Standards:

We will strive to have a variety of arts and crafts available and will provide the equal opportunity for any types of vendors that are interested in vending at the craft fair.

Exhibitors are prohibited from displays that include any type of offensive/obscene material.

#### Security:

Each exhibitor is responsible for his/her own display. Neither the Town, nor any other participant will assume any responsibility in the event of loss or damage of any kind by any cause. On-premise security is not provided for the event.

#### **Booth Setup:**

Exhibitors may register and set-up on Friday afternoon from 2:00 – 5:30 p.m. or Saturday morning between 6:00 – 8:00 a.m. Failure to register and set-up prior to 8:00 a.m. may result in forfeiture of space. All exhibitors must furnish their own tents, tables, and display equipment. All display items must be maintained within designated booth space.

#### Other Notes:

You will receive notice of booth approval via email. Any modifications to these requirements may be made on a case-by-case basis as determined by the TSCA.

Booth placement will be determined by the **TSCA**. We cannot guarantee accommodations for special requests such as electricity, shade or location. **Please note:** If you want to be located next to a certain vendor, please submit your applications together in the same envelope in order to be date received together. Thank you for your attention to this matter.


